BYLAW NO. 1153

A BYLAW TO AMEND “BUSINESS LICENSE BYLAW NO. 898 (1998)”

THE COUNCIL OF THE DISTRICT OF NORTH SAANICH, in open meeting assembled, enacts as follows:

I. AMENDMENTS

Bylaw No. 898, being “Business License Bylaw No. 898 (1998)”, is hereby amended as follows:
